- 1) After completion this form must be submitted to the DCA, together with the following:
 - a) For the INITIAL issue of an instructor rating:
 - i) results of the theoretical knowledge examination for Grade III applicants;
 - ii) results of the TRI course for TRI applicants;
 - iii) proof of completion of the required patter for Grade III and TRI applicants;
 - iv) Proof of completion of 5 sectors under supervision of Gr I or II for TRI applicants;
 - v) proof of completion of the ground evaluation test;
 - vi) results of instructor rating skill test;
 - vii) logbook, properly summarised and certified by a designated examiner or DCA inspector;
 - viii) instructor rating fee as prescribed in Part 187.
 - b) For an initial FSTD authorisation, the results of the type rating course, type rating skill test, presentation under supervision and FSTD skill test must be submitted with application.
 - c) For the REVALIDATION of an instructor rating:
 - i) Proof of completion of instructor refresher seminar;
 - ii) Results of the instructor rating skill test;
 - iii) Logbook, properly summarised and certified by a designated examiner or DCA inspector.
- 2) All skill test reports must be submitted within 30 days of completion of the skills test.
